

## Rural Generalist Medicine Prevocational Certification checklist

We coordinate a prevocational training program that is designed to ensure access to a broad range of education and experience during prevocational training to prepare trainees for progressing to supervised rural practice or advanced skills training (AST). Trainees are assessed against prevocational certification requirements, by completing the prevocational training program, at the end of postgraduate year 2 (PGY2). The table below provides a summary of requirements.

Satisfactory completion of the Rural generalist trainee workshop series	Signed attendance register provided by workshop coordinator.	Workshop coordinator.	
Completion of the QRGP Community preparation module	Successful completion of module. The team will be automatically notified upon completion via the iLearn system. Contact the team for details on how to enrol in the module.	QRGP to obtain from iLearn.	
Assessment of personal and professional readiness (including clinical confidence and capability; and appropriate advanced skill interest) to commence practice in a rural area	Assessed by RGTA at career planning interviews (PGY1 & 2) and in consultation with Director of Clinical Training (DCT) at trainee's employing hospital.	RGTA.	

We will not be able to assess your eligibility to attain Rural Generalist Medicine prevocational certification if we don't receive your evidence by the deadline we nominate when we contact you.





You should also ensure you:

- have considered, and sought advice from, your Rural Generalist Training Advisor (RGTA) regarding when to apply for general practice training with the Royal Australian College of General Practitioners (RACGP) or Australian College of Rural and Remote Medicine (ACRRM)
- advise the QRGP team of any change to personal contact details via: rural\_generalist@health.qld.gov.au
- contact your RGTA with any concerns with hospital terms or any other issues requiring advice and support
- maintain consistent contact with the QRGP team regarding your career intentions
- consider your preferred AST discipline and ensure you are ready to apply for it by April of PGY2wanting to commence training in PGY3. The QRGP team will provide more information and reminders closer to the time.
